Eligibility for Show and Awards

- All residents of the Michiana area, 18 years and older, in Indiana or Michigan.
- Two-Dimensional work in any media, excluding photography. Only ORIGINAL work completed in the last two years will be accepted. Slides are not accepted.
- Two entries only, per artist.
- All entries should be prepared for display, not to exceed 40 inches in either direction, horizontal or vertical, including matting and/or framing. All entries must be prepared for display with suitable hanging devices.

- Completed Entry Form.
- Completed Jurors' Results return card with stamp.
- Individual Works Entry Label (s) filled out and attached to the art entry on the back, bottom right corner of the art.
- Entry fee of \$10 per entry included with Entry Form. Make checks payable to: Goshen Painters' Guild.
- Up to Two (2) ORIGINAL Works.
